Birmingham Orthotic Services are committed to being a Net Zero emissions company by 2050.

Baseline Emissions Footprint: Year 2023

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

Emissions reduction targets

As this is our first carbon reduction plan, we are going to adopt the following reduction targets:

We project that our carbon emissions will decrease over the next 5 years to 58 tCO²e by 2029. This is a reduction of 7%.

Carbon Reduction Projects

These following are examples are projects that are either are or in the process of being implemented in order to reduce our emissions:

- Electric Vehicle options to be open to both company and personal staff vehicles.
- Continuously monitor electric and gas usage and explore areas we can save.
- Look at alternative premises that will enable us to invest more into Net Zero.
- Encourage more online sales meetings to reduce road milage of company vehicles.
- Explore ISO50001 and ISO14001 certifications and ways we can manage energy consumptions.
- New technologies to be investigated to become both efficient in manufacturing and energy usage.
